- Original leather or vinyl (often found underneath cushions or pull some staples from the frame)
- Cushion case
- Fuse panel cover or headrest from a vehicle
- Paint chip from a hardware store (beware, the grain of leather/vinyl can alter color appearance)

The bigger the better, at least 3" x 1" in size, though we have worked with smaller.

***If you send an irreplaceable or valuable component such as a headrest or cushion case, please insure the item with the freight carrier in the event it is lost or damaged!***
